IRCC CLUB POLICIES

- 1) All club meetings will be conducted with a high degree of decorum. Personal issues and comments directed at other club members will not be tolerated. Persons conducting themselves in this manner will be considered out of order, and the discussion will be terminated.
- 2) Flying is restricted to current IRCC club members and their guests. Sponsoring club members must be present at all times and are responsible for their guests. Guests are AMA members who are not current IRCC members and were not IRCC members in the previous six months. Guest will be permitted to fly up two days per calendar year. If any guest wants to fly more than two days, he/she must become member. Sponsoring IRCC member must sign themselves and guest in on sign-up sheet located in glass cabinet at field. This will be strictly enforced.
- 3) IRCC members may receive a copy of meeting minutes upon request.
- 4) Any member causing damage to a person or property at the Imperial RC Club should make every effort to remedy the damage either on their own with the individual who sustained the injury or damage and/or follow the Academy of Model Aeronautics insurance claims process when allowable.
- 5) New members joining the club will pay an introductory rate of \$100. A new member is defined by the IRCC has any member who has not been a member of the IRCC for the preceding 24 months.
- 6) Any new or renewing member who wishes to join the IRCC may do so by exhibiting a current AMA card, and paying the proper dues amount to a club officer. Membership rates are as follows:

Adult Member	\$200	(may pay \$100 every 6 months, see treasurer to get approval)
Junior Member	\$1	
Associate Member	\$30	
Visitor	\$25	(Allows access to IRCC for 7 days only with proof of current AMA)
Winter Member	\$100	(Must show proof of non-Florida residency via Driver's License, Power Bill or Voter Registration Card. Eligible to fly at IRCC for six months)
- 7) The IRCC will not be responsible for personal items left at the club flying field. Member's personal property left at the field will not be replaced by the club if lost, damaged or stolen.
- 8) Any complaint directed at and / or regarding the Imperial Radio Control Club that originates from sources outside the IRCC must be delivered to the current IRCC President. Any complaint delivered as described above, shall be presented by the President to the general membership at the next regular club meeting for response considerations.
- 9) Hosting Special Flying Events:
 - a) Any IRCC member wishing to have an event at the IRCC flying field or other location associating with the IRCC, must first submit a proposal to the executive committee. The executive committee will review the proposal, and the proposal will be presented at the next

regular meeting for consideration. The proposal should include an outline highlighting, but not be limited to the following information:

Type of event

Date for the event, including set-up and tear-down.

Manpower requirements

Financial commitment required from the club

Benefits expected

c) Upon approval, the CD shall assume responsibility for all activities on the property. The CD will coordinate with club officials, officers and members to assure that all tasks are properly completed, and the IRCC is represented in its, "Best Light".

d) No formal events may take place at the IRCC flying field on traditional holiday weekends, and the day (days) immediately preceding or following them. (New Years, Easter, Memorial Day, 4th of July, Labor Day, Thanksgiving, Christmas, etc.)

e) A CD not properly fulfilling their responsibility may be subject to disqualification as a CD for future IRCC events. This determination will be made by the Executive Board, and will be confirmed at the following regularly scheduled meeting.

10) IRCC Turbine Policy / Policy #10 Approved at the December 2011 IRCC Meeting

a) This policy applies to all turbine operations at the current IRCC Flying site at Mulberry Fla.

b) The IRCC will issue IRCC turbine authorizations under certain conditions which follow. These will be for regular IRCC members who have paid 100% of the annual dues for the current year. The fee for this special authorization will be fifty dollars (\$50) per calendar year. No junior members, winter members, associate members or guests. No exceptions.

c) A current AMA turbine waiver / license is required to request an IRCC turbine authorization. AMA card with turbine waiver must be on person of pilot and IRCC membership card with turbine authorization must be in 2.4 card section at all times turbine is in operation. No exceptions. IRCC turbine authorization will be an IRCC membership card with "turbine authorized" typed at the bottom.

d) All AMA rules, including but not limited to turbine waivers, safety, and all related costs of complying therewith and the costs of complying with additional club conditions are solely the responsibility of the turbine flyers. No club general revenue will be used to offset cost of turbine flying. Additionally, all turbine flyers will have their own spotters and the AMA rule for fire suppression is hereby clarified to mean a mobile tank containing at least 5 gallons of water to be on hand whenever a turbine is in operation. All turbine flying will be done from the East-West runway.

e) All turbine models will operate on 2.4 radio systems.

f) Turbine flying will only be allowed on Saturdays and Sundays after 12 noon. All members retain full access to the field at these times, whether or not turbines are present.

g) Turbine Engines will be limited to 30 lbs. of thrust. No detuned engines. One gallon "on board" fuel capacity.

h) Notwithstanding all other rules, the policing of each turbine flyer is the responsibility of every turbine flyer as well as the members. It will be the added responsibility of turbine flyers to make sure that all turbine flyers are safe.

i) All turbines will start up in a designated turbine start up area at least 50 feet west of the main shelter.

11) Children of members or other children – under the age of 16 may not be left at the IRCC flying site without prior arrangements being made for pick up. At no time shall children of members or other children be left at the IRCC flying site without supervision. An IRCC member must be present.
